



# Terms of Business

## Summary

We will always do our best to fulfil your needs and meet your goals, but sometimes it is best to have a few simple things written down so that we both know what is what, who should do what and what happens if stuff goes wrong. In this contract you won't find complicated legal terms or large passages of unreadable text. We have no desire to trick you into signing something that you might later regret. ## In short

You are hiring us (The Little Design Studio) located at The Studio, Barnwell, Peterborough PE8 8PW to carry out the work as described in the attached Proposal for the estimated total price given in the Proposal. Of course it's a little more complicated, but we'll get to that.

## What do both parties agree to do?

As our customer, you have the power and ability to enter into this contract on behalf of your company or organization. You agree to provide us with everything that we need to complete the work including text, images and other information as and when we need it and in the format that we ask for. You agree to review our work, provide feedback and sign-off approval in a timely manner too. Deadlines work two ways and you will also be bound by any dates that we set together. You also agree to stick to the payment schedule set out at the end of this contract.

We have the experience and ability to perform the services you need from us and we will carry them out in a professional and timely manner. Along the way we will endeavour to meet all the deadlines set but we can't be responsible for a missed launch date or a deadline if you have been late in supplying materials or have not approved or signed off our work on-time at any stage. We cannot be responsible for delays caused by matters beyond our control (Force Majeure they call it). On top of this we will also maintain the confidentiality of any information that you give us.

## Imagery

You will supply us imagery in the format we request for either print or web use. If you choose to buy stock photographs we can suggest vendors of stock photography. Any time we spend searching for appropriate photographs will be charged at our hourly rate as detailed in the Proposal.

## Changes and revisions

We know from plenty of experience that fixed-price contracts are rarely beneficial to you, as they often limit you to your first idea about how something should look, or how it might work. We don't want to limit your options or your opportunities to change your mind about something.

The estimate/quotation prices in the Proposal are based on the number of days that we estimate we'll need to accomplish everything that you have told us you want to achieve. If you do want to change your mind on something, e.g. add extra pages to a website, change the nature of your print needs, or introduce a new concept to your branding, that won't be a problem. You will be charged the daily/hourly rate set out in the estimate we gave you along with any additional costs and expense that would be incurred to meet your revised requirements. We will of course explain these costs and charges to you and may submit them to you in a Revised Proposal. Along the way we may also ask you to put certain requests in writing so we can keep track of changes.

We offer 14 day support to cover any technical errors on your website upon transfer from the date of launch. This does not include any damage to the website due to user error of the client.

We can't guarantee that the functions contained in any web page templates or a completed web site will always be error-free and so we can't be liable to you or any third party for damages, including lost profits, lost savings or other incidental, consequential or special damages arising out of the operation of or inability to operate this web site and any other web pages, even if you have advised us of the possibilities of such damages.

If any provision of this agreement shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this agreement and shall not affect the validity and enforceability of any remaining provisions.

We will undertake best endeavours to ensure we have obtained the necessary permissions to use any elements of text, graphics, photographs and design that we may include in our work for you.

You guarantee to us that any elements of text, graphics, photos, designs, trademarks, or other artwork that you provide us for inclusion in the work we are doing for you are either owned by you, or that you have permission to use them.

When we receive your final payment, copyright is automatically assigned as follows:

You own the graphics and other visual elements that we create for you in this work. We will give you a copy of all files and you should store them really safely as we are not required to keep them or provide any native source files that we used in making them.

You also own text content, photographs and other data you provided, unless someone else owns them. We own any background software (eg the XHTML markup, CSS and other code) and we license it to you for use on only for this piece of work.
